

Lively, 19, a Negro from Philadelphia, didn't know they were going to court for a hearing yesterday until they were taken from the jail. The defendants told Magistrate Leonard Lockhart they wanted a Congress of Racial Equality lawyer, then in Baltimore, to represent them. The judge then postponed the hearing.
