

## Translation of Narova Complaint

### The Statement of Article 184 of the Criminal procedure code of the Russian Federation About the Action of Criminal Case

I, Stanina Rimma Mikhailovna, are the General Director of limited liability companies (Perfomaco) OJSC (081111000421), (Swallowtail) OJSC (081110004408) OJSC (0000000000000), appointed by decision of the sole shareholder of these societies - Company Boly Systems LTD. - From February of 2008.

Company Boly Systems LTD, Registered in the British Virgin Islands and operates in the Russian Federation through the authorized representative Smetanki, Nikolayevich Turayevich. In February 2008 the company signed in Kazan, the contract for the purchase by LLC Plado (Kazan, Demianovskiy St. 22) shares in the Charter capital of 000 (Perfomaco), 000 (Swallowtail), 000 (Hyland) 100% of the share of capital of each society.

These companies intended to use to purchase on their behalf a number of shares in Russia, including shares of, (Sagorant), objects of real estate. Previously, **these companies were the largest shareholders of OAO (Sagorant)**, have a securities account in the Depository center of (SAG) (Sagorantbank)

However, after the acquisition of shares in the charter capital (Hyland) (Perfomaco) (Swallowtail), we know that the unidentified person who is registered companies 000 (Swallowtail), 000 (Perfomaco), 000 (Hyland), The name of the new participant **(Plado), issued the companies large loans** in the amount of several billion rubles.

In particular, on behalf of (OAO (Sagorant Plus) 000 (Inter), 000 (Grand Active)) in arbitration courts, first and foremost, St. Petersburg and Leningrad Region (Business No. 456-22481/2007\_456-22484/2007, 456-22476/2007, 456-22474/2007, 456-22475/2007, 456-22473/2007) then Moscow (Business No. 440-04496/07, 440-04496/07, 440-04500/07, 440-04501/07, 440-04502/07) and in the end the republic of Tatarstan (Business No. 405-20685/2007) was presented numerous statement of claim about collective from 000 (Perfomaco), 000 (Swallowtail), 000 (Hyland) Loss of a significant amount of several million rubles in each petition. Indeed, during 2004-2006 had me companies were active in the economic activities of buying and selling shares (Sagorant) the second issue with a nominal value of 1) rubles, state registration number 1-61-0000084, has the Federal Securities Commission of Russia for the implementation of public transactions for the purchase and sale of securities data, all these societies were open accounts in the depository (SAG) center AB (Sagorantbank) (SAG), currently remained to (IC (Sagorantbank)). In January of 2008 had had me societies, 000 (Swallowtail), 000 (Perfomaco), 000 (Hyland) the shares were sold to a number of foreign companies for the sold shares was the cash received from customers, which, in turn, was directed to the statutory purpose.

At the same time, according to the information available to me, (SAG (Sagorant Plus), 000 (Inter), and 000 (Grand Active)), applying to arbitration courts, demanded me to organizations for damages caused by failures of the supply agreements dated 12 April 2005, 12 May 2005, 17 May 2005, in
