


Here is a [report](#) by Michael Thau that goes into detail to prove another Browder forgery, the “baton” story.

Handcuffs were used in connection with the threat of committing an act of self-mutilation and suicide

(specifics: reasons and circumstances of application)  
Handcuffs were removed at « 20 » hrs. « 00 » min. « 16 » November 2009.
