Please note that the information sent via the Commission's emails dated 19 October 2018 and 1 November 2018, both indicate what the Commission has in its files concerning UBS (Bahamas) Ltd. (In Liquidation) and its registered personnel for the year 2013. Note that the information provided indicates what services UBS (Bahamas) Ltd. (and by extension, its registered personnel) was registered to provide/engage in during 2013, and their registration status remained the same throughout the year 2013.

Your query below, and the subject line, appear to relate to another entity (i.e. UBS AG), which is not reflected in the Commission's records as a registrant.

The Commission is unaware of the context of your queries, noting that you are using statutory provisions which may or may not relate to the information provided. Therefore, note that this and any other information provided is given solely in response to your emailed query concerning registration status of entities, and is provided "as is" without any assurance that it concerns the provisions you have cited.

Clarification, should it be required, will need to be obtained from the Commission via a formal written request for same.

Thank you again for Your message timed 13:07, 1st November 2018, which answered the second part of our first query regarding associated or shared premises with UBS (Bahamas) Ltd. registered to carry on the securities business by the Commission in the period 12th June to 10th October 2013 for the purpose of Sections 71 and 74 of the Securities Industry Regulations, 2012.

With the present we address to You our second query regarding UBS AG's approval or registration with the Commission to provide custody services in the period 12th June to 10th October 2013.

The purpose of this query is proof of compliance of UBS AG with Section 20 of the Securities Industry Act, 2011, which reads:

"20. A company desiring to provide clearing, settlement, depository, custody or other services which facilitate or are ancillary to the operations of a Securities Exchange may not do so until it has been approved and registered by the Commission which shall have the exclusive authority to approve and register companies engaged in such services, and such company shall be referred to individually as a "facility".
